NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Wednesday, December 7, 2022, at 1:00 p.m.

The Board shall consider and/or act on the following matters:

1. Comments from the public;
2. Review and approve the minutes of the November 9, 2022, Board of Directors meeting;
3. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented;
4. Ratify termination of Second Amended and Restated Agreement for Bookkeeping Services between the District and Municipal Accounts & Consulting, LP;
5. Consider approval of Agreement for Bookkeeping Services between the District and Clarity Consulting Corporation;
6. Adoption of Amended Order Establishing Policy for Investment of District Funds and Appointing Investment Officer;
7. Approval of amended District Registration Form relative to above and authorize filing of same with the Texas Commission on Environmental Quality;
8. Authorize preparation and maintenance of a local government officers list in connection with conflict of interest disclosure documents;
9. Review activity reports and/or receive updates regarding Fort Bend County Precinct 1 Constable's Office ("FBCCO");
10. Status of conversion to LED bulbs and painting of the decorative light poles in the community by CenterPoint Energy;
11. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
12. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;

 - c. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - d. Discussion regarding North Fort Bend Water Authority ("NFBWA") effluent reuse program; and
 - e. Proposal for Geographic Information System;
14. Proposed agreement with Texas Department of Transportation regarding the construction of a noise barrier along State Highway 99;
 15. Report by Champions Hydro-Lawn, Inc., regarding maintenance of drainage facilities;
 16. Status of compliance with the Texas Commission on Environmental Quality Phase II Small MS4 General Permit, including public comments and any training that is necessary under the Storm Water Management Plan ("SWMP");
