NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Wednesday, April 5, 2023, at 1:00 p.m.

The Board shall consider and/or act on the following matters:


1. Comments from the public;
2. Review and approve the minutes of the March 1, 2023, Board of Directors meeting;
3. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented;
4. Status of continuing disclosure report (due March 30, 2023);
5. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
6. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;
7. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Real Property Taxes and Authorize the delinquent tax attorney to pursue the collection of delinquent real property taxes beginning July 1, 2023, including the filing of lawsuits, as necessary;
8. Review activity reports and/or receive updates regarding Fort Bend County Precinct 1 Constable's Office ("FBCCO");
9. Engineering Report, including:
 - a. Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of TEC Form 1295;
 - b. Status of construction contracts, including the approval of any pay estimates, change orders and/or acceptance of facilities for operation and maintenance purposes, including:
 - (i) Construction of North Outfall Detention Pond Side Slope Rehabilitation utilizing the SOX erosion repair system (Storm Water Solutions, LLC);
 - (ii) Little Prong Creek North and South Slope Erosion Repair (AR Turnkey Construction Company, Inc.); and
 - (iii) Installation of permanent emergency generator at the District's remote water

- well (McDonald Municipal and Industrial);
- c. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - d. Discussion regarding North Fort Bend Water Authority ("NFBWA") effluent reuse program;
 - e. Status of implementation of Geographic Information System by BGE, Inc.; and
 - f. Consider approval of proposal for concrete materials testing in connection with the installation of the generator at the District remote water well;
10. Status of communications regarding proposed construction by the Texas Department of Transportation of a noise barrier along State Highway 99;
 11. Report by Champions Hydro-Lawn, Inc., regarding maintenance of drainage facilities;
 12. Status of compliance with the Texas Commission on Environmental Quality Phase II Small MS4 General Permit, including public comments and any training that is necessary under the Storm Water Management Plan ("SWMP");

 - j. Discussion regarding proposed installation of commemorative bench at the Family Park;
 - k. Annual report regarding status of District's Identity Theft Prevention Program ("Program"), including discussion of Program compliance, staff training, effectiveness and suggested changes; and
 - l. Authorize preparation of draft Consumer Confidence Report for review by Board of Directors;
 14. Status of Annual Implementation Report regarding Water Conservation Plan and the filing of same with the North Fort Bend Water Authority (due May 1, 2023);
