NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Wednesday, June 7, 2023, at 1:00 p.m.

The Board shall consider and/or act on the following matters:


1. Comments from the public;
2. Review and approve the minutes of the May 3, 2023, Board of Directors meeting;
3. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented;
4. Approval of Unclaimed Property Report as of March 1, 2023, and authorize bookkeeper to file Report with State Comptroller prior to July 1, 2023;
5. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
6. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;
7. Review activity reports and/or receive updates regarding Fort Bend County Precinct 1 Constable's Office ("FBCCO");
8. Engineering Report, including:
 - a. Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of TEC Form 1295;
 - b. Status of construction contracts, including the approval of any pay estimates, change orders and/or acceptance of facilities for operation and maintenance purposes, including:
 - (i) Little Prong Creek North and South Slope Erosion Repair (AR Turnkey Construction Company, Inc.); and
 - (ii) Installation of permanent emergency generator at the District's remote water well (McDonald Municipal and Industrial);
 - c. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - d. Discussion regarding North Fort Bend Water Authority ("NFBWA") effluent reuse program; and
 - e. Status of implementation of Geographic Information System by BGE, Inc.;

9. Status of communications regarding proposed construction by the Texas Department of Transportation of a noise barrier along State Highway 99;
10. Report by Champions Hydro-Lawn, Inc., regarding maintenance of drainage facilities;

 - e. Report regarding water accountability;
 - f. Status of maintenance of the District's park facilities; discussion regarding use of parking lots for overnight parking;
 - g. Program to reduce the use of flushable wipes within the District;
 - h. Status of replacement of the drum screen at the Joint Wastewater Treatment Plant;
 - i. Discussion regarding proposed installation of commemorative bench at the Family Park;
 - j. Discussion regarding proposed joint community event to be held in collaboration with No. 34; and
 - k. Submission of updated contact information and/or descriptive information regarding District facilities that qualify for critical load status to the County Office of Emergency Management, Public Utility Commission, and the Division of Emergency Management of the Governor, relative to compliance with Section 13.1396, Texas Water Code;

14. Authorize completion, execution and filing with the Secretary of State of Voting System Annual Filing Form relative to District elections;

18. Convene in Closed Session pursuant to Open Meetings Act, Section 551.071, Texas Government Code, for consultation with the District's attorney regarding pending or threatened litigation or matters protected by attorney-client privilege;
19. Reconvene in Open Session and authorize any action resulting from discussions in Closed Session; and

20. Matters for possible placement on future agendas.
