## NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

## The meeting will be held on Wednesday, April 3, 2024, at 1:00 p.m.

The Board shall consider and/or act on the following matters:

- 1. Comments from the public;
- 2. Review and approve the minutes of the March 6, 2024, Board of Directors meeting;
- 3. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented;
- 4. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
- 5. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;
- 6. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Real Property Taxes and Authorize the delinquent tax attorney to pursue the collection of delinquent real property taxes beginning July 1, 2024, including the filing of lawsuits, as necessary;
